Subject:- Last and Final Notice for the construction and maintenance of Pethgam to Renie Road Package No. JK04-486 Block Marwah District Kishtwar.

The contract of the above noted Road project under subject is allotted to you by the Superintending Engineer PMGSY Circle Batote vide allotment No. PMGSY/SE/B/441-47 dated 03-05-2019 with the stipulated completion period of 12 months to be reckoned w.e.f. 18-05-2019 from the 15 days of allotment. You are well aware of the fact that the intended completion period of 12 months had already come to its end during the year 2020 and further delay of 04 years without any execution you are not in a position to complete your allotted work and have left abandoned since last year and are therefore in total breach of the contract terms and conditions. Due to your persistent and sustained defaults final notice were served upon you last year vide No. 787-93 dated 21-07-2023 and final notice highlighting all your defaults and defects but even you should not any interest or genuine intention to execute the work as per the project milestone dates mentioned in revised milestone and thereby having no option left but to submit the termination case of your contract to Superintending Engineer PMGSY Circle Batote vide No EE/PMGSY/M/968-70 dated 31-07-2023. after coming to know about the termination of your contract you rushed to the office of Superintending Engineer PMGSY Circle Batote as well as Chief Engineer PMGSY (JKRRDA) Jammu with Firm commitments to start the work within 15 days and ultimately you started blacktopping of Road but succeeded in completing only 4.00 Kms out of 7.50 Kms due to your deficient resources for which you assured to get the remaining work completed in next working season of 2024 within the month of June-July 2024, with the start of working season right from May 2024, you have been requested number of times to resume the balance work of BT with immediate laying of GSB,WBM/ construction of CD/Protection works with deployment of sufficient resources of men, machinery, material and equipments but on every occasion you gave firm commitments for starting the same within weeks time which later on proved false. Half of the working season in the area has passed but still you are not in a position to resume the balance work which clearly exhibit your non-seriousness to execute the project for its completion and is causing a huge loss to the Govt exchequer. The public of the area is aggrieved by the act of your sustained default and it has been observed that your actions are deliberately hindering the Government work and creating unnecessary delay to complete the project within the timeline fixed. You have literally ignored the inconvenience, wastage of zme and money of the public discomfort which is being faced by the public of the area due to non completion of the project.

In the backdrop of the aforesaid non exhaustive fundamental breaches to the contract and in view of your persistent and sustained defaults you are once again notified through the medium of print media with reference to earlier communications given the last opportunity to resume the work within 05 days from issue of this notice letter for completion of balance work. In case you fail to resume the balance work within 05 days from the date of issue of this final notice to you through the print media the balance work shall be put a fresh tender at your risk and cost with termination of your contract along with imposition of all penalties, liquidated damages and you will be recommended to be blacklisted by the competent authority which you should note very carefully. No other correspondence shall be made to you in this regard in future and this may be treated as last/final notice.
