#### Stopping cycle of deaths at **Badhaal top priority: Omar**

"I appeal to everyone to allow the concerned agencies to perform their duties. Identifying the reasons behind these tragic deaths is our utmost priority, and we are committed to taking steps to prevent such occurrences in the fu-

A high level inter-ministerial team on Monday visited Badhaal to ascertain the cause of death of 17 members of three families under mysterious circumstances.

The central team headed by a director-rank officer in the Ministry of Home Affairs reached Rajouri district headquarters on Sunday evening and received a briefing from senior district, health and police officers, officials

Home Minister Amit Shah had ordered the constitution of the inter-ministerial team to ascertain the causes of deaths in the three families linked to each other in a remote village, about 55 km from Rajouri town, between December 7 and January 19.

Officials said the team, accompanied by dozens of senior officers of various departments, reached Badhaal at about 11.30 am and visited the bereaved families even as grave diggers were preparing the last resting place of Yasmeen Kousar (15), the sixth child of Mohammad Aslam who breathed her last at the SMGS hospital in Jammu on

The central team divided itself in two groups immediately after reaching the village and undertook their investigation, officials said.

Nine members of two families had died in the village between December 7 and 12.

According to officials, the central team, in collaboration with the local administration, will work on providing immediate relief as well as taking precautionary measures to prevent such incidents in the future.

The patients complained of fever, pain, nausea, intense sweating and loss of consciousness before dying within days of their admission to hospitals.

Earlier, a Jammu and Kashmir government spokesperson said investigations and samples empirically indicated that the incidents were not due to a communicable disease of bacterial or viral origin and that there is no public

Authorities recently sealed a spring in the village after its water was tested positive for some pesticides/insecticides.

He urged the presiding officers to digitise all debates in the respective legislative bodies, asserting that Parliament would provide all possible technical support.

Bihar Governor Arif Mohammad Khan, while addressing the presiding officers, said the Constitution reflected the ancient values, and the decisions taken at the conference would further strengthen the democracy.

Khan said the origin of the Panchayati Raj system could be traced back to the ancient Indian republics, where the governance system was based on democratic principles.

He said that in ancient India, instead of hereditary monarchy, democratic systems prevailed, such as in Vaishali, where rulers were chosen by the people.

He added that Dr. B.R. Ambedkar had acknowledged the ancient heritage of Indian democracy during the drafting of the Constitution.

He also spoke about the rich contribution of Bihar in the nation's freedom struggle and the drafting of the Constitution. He asserted that the Constitution was not just a legal document but also a symbol of the nation's ideals and objectives.

#### **Trump declares end to** birthright citizenship

claring illegal immigration at the border a national emergency, he swiftly made moves on his promises to tighten the US-Mexico border.

But some of his plans - particularly around changing the definition of birthright citizenship - were likely to face significant hurdles. He is already facing legal challenges from immigration advocacy groups, which have reacted furiously to his announcements.

One organisation said his plans "do not uphold American values", and another said Trump's administration was "actively trying to destroy our lives".

In his inaugural address earlier in the day, Trump vowed that "all illegal entry will be halted" and that millions of "criminal aliens" would be deported.

He also signed an order declaring Mexican drug cartels terrorist organisations. "I have no higher responsibility than to defend our country from threats and invasions," he

At another event at Washington's Capital One Arena, Trump formally revoked nearly 80 executive actions of his predecessor Joe Biden. He had previously vowed to scrap Biden's policies "within five minutes".

Following his inauguration, he also signed a proclamation that gave officials the authority to "repel, repatriate, or remove" migrants until he was satisfied that "the invasion at the southern border has ceased".

Although the details of the order were not yet known, officials said that Trump plans to end birthright citizen-

That refers to an approach of the US government whereby anyone born on American soil is considered a citizen at birth, regardless of their parents' immigration sta-

Trump appears to be seeking to change the rules so that that the children of undocumented migrants living in the US will no longer automatically be considered US citizens.

It would not apply retrospectively. Exactly how he intends to achieve this is unclear, however, because birthright citizenship is enshrined in the constitution and would require a two-thirds vote in both

chambers of Congress to change. Trump has instructed federal agencies to stop issuing documentation to children born in the US to parents who are in the country illegally or on temporary visas, which could effectively deny them access to public services.

Advocacy group the American Civil Liberties Union (ALCU) immediately said it was suing the Trump administration over the order. "Denying citizenship to US-born children is not only unconstitutional - it's also a reckless and ruthless repudiation of American values," it said in a state-

## **ED** attaches 2 hotels at Patnitop

NEW DELHI, JAN 21: The Enforcement Directorate has attached two hotels, valued at about Rs 15 crore, in the tourist town of Patnitop in Jammu and Kashmir as part of a money laundering investigation.

The federal agency said in a statement on Tuesday that the two facilities — Hotel Trinetra Resorts and Hotel Green Orchid — were built "beyond" the area permitted by the Patnitop Development Authority (PDA).

A provisional order was issued by the ED to attach the hotels under the Prevention of Money Laundering Act (PMLA).

The two immovable properties are valued at Rs 14.93 crore.

The money laundering case stems from a CBI FIR that was filed against vari-

ous owners and directors of

hotels, guest houses, resorts, cottages and residences in Patnitop area apart from PDA officials. It was alleged in the CBI

complaint that these hotels "indulged in" commercial use of residential buildings, made excess construction beyond approved limits and operated their businesses in prohibited areas (dense forests, agricultural areas, residential areas, etc.) and these alleged lapses were "overlooked" by PDA officials.

"Hotel Trinetra Resorts and Hotel Green Orchid were built beyond the area permitted by the PDA," the agency said. "Both had undertaken il-

legal construction beyond approved limits and acquired illegally encroached land while generating revenue from utilising the same," the ED said.

# J&K achieves 85% completion rate under PMAY-G: Secretary RD&PR

jouri here. The meeting besides Secretary Health & Medical Education Department was attended by ADGP, Jammu; Divisional Commissioner, Jammu; DIG, Rajouri-Poonch Range; DC, Rajouri; Rajouri; Principal, GMC, Jammu; Principal, GMC, Rajouri; Director, Health Services, Jammu besides some experts from the national health institutions. During this meeting the

Chief Secretary impressed upon the concerned from Health and Police Departments to take stringent containment measures in consultation with the Divisional administration to ensure that there is no further loss of any life. He advised the concerned

to frame a proper SOP for

monitoring the population of the village. He asked them to deploy sufficient manpower from both the Health department and Police to enforce the Do's and Don'ts set in the SOP. Dulloo further enjoined

upon the divisional and district administration to not let down their guard and allow only tested edibles and non-edibles to be used by the persons under quarantine. He stressed that till the actual causes of these deaths are not known both the Police and Health professionals should carry on their investigations as required as per the set procedures.

He also urged them to study the reports received from the national diagnostic institutions that had taken samples from the village. He directed them to take every possible measure to protect the lives of these villagers till the toxicology reports point out the actual causes of these deaths.

He also took note of the

work done so far by the SIT constituted by the Police Department and other investigation agencies including the Ministerial team sent by the Ministry of Home Affairs. He enquired from the experts the possible preventive measures that could be taken to control the further damage. The Secretary H&ME, Dr

Syed Abid Rashid Shah informed the meeting that every measure has been taken to isolate the families and provide them food and water after testing the same. It was given out that the

health teams are stationed there to keep surveillance for any of the symptoms appearing in any person. It has further been added that the local PHC/CHC has been kept in a state of readiness besides it is ensured that no food or eatables are exchanged as the families had been removed from their homes and kept under continuously monitored to safeguard their lives.
